The Personal Support Worker ("PSW") Registry of Ontario ("Registry") Registrant Website Terms of Use Agreement ("Agreement") sets out your responsibilities while using the Registry's website. Please read the information below carefully. Terms of Use

Introduction

The PSW Registry ("Registry,") provides this web site, which includes (www.psw-on.ca), all site-related services, and authorized mobile device applications (collectively, the "Site"). This Agreement governs Site visitors' and/or participants' ("you") use of the Site. You must carefully read and understand the terms and conditions of this Agreement. By using the Site, you agree to be bound by this Agreement. If you do not agree, you may not participate in the Registry or use the Site. Please also read the Registry's [Privacy Policy](#).

Changes

THE REGISTRY MAY AT ANY TIME AND WITH IMMEDIATE EFFECT:

- change the terms and conditions of this Agreement; and/or
- change the Site, including eliminating or discontinuing any content on or feature of the Site.

If you continue to use the Site after any change, you will be deemed to have accepted the change. You must periodically review this Agreement to ensure familiarity with the most current terms and conditions.

Application Form and Related Materials

Application forms and other information and materials provided through the Site, including any data, text, graphics, images, audio and video clips, logos, icons and links (collectively, the "Materials"), are intended to educate and inform you about the Registry and the Site. Unless otherwise specified on the Site, you may download the forms accessible through the Site. You must retain all copyright and other proprietary notices on downloaded and copied Materials. The Materials remain the property of the



Registry or its licensors or suppliers. You may not download, copy, or use any of the Materials except as expressly authorized. You may not distribute, modify, transmit or publicly display the Materials except as permitted in writing by the Registry.

Protecting your Login

As part of the registration process, you will be assigned a username and password. You will be responsible for maintaining the confidentiality of your username and password. You must not share, transfer or sell your use of or access to the Site to anyone. If you believe that your account with the Registry is no longer secure, you must promptly change your password and notify the Registry of the problem by email, fax, or mail to the address below. **YOU ARE ENTIRELY RESPONSIBLE FOR MAINTAINING THE CONFIDENTIALITY OF YOUR USERNAME AND PASSWORD AND FOR ANY AND ALL ACTIVITIES (INCLUDING APPLICATIONS, APPEALS or OTHER INFORMATION) THAT ARE CONDUCTED THROUGH YOUR ACCOUNT.**

Appropriate Use of Site

While using the Site or Materials, you must not:
